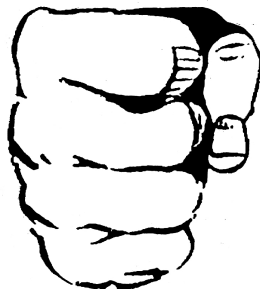

CHAIRMAN'S REPORT

Without the tireless efforts of the Association's Secretary – Heather Dewar, it is likely that this organization would by now exist in name only. She has been energetic in meeting with politicians, monitoring the avalanche of policy documents emanating from various Government Agencies and in actively investigating the likely impacts on members. She has contributed hundreds of hours of voluntary time, driving from Gingin to Perth on a weekly basis to keep the flame alight. Thanks to her the accounts are meticulously recorded. We owe her our unreserved gratitude and support.

Our thanks also to Linda Macri who is likewise, a tireless monitor of government propaganda, keeping us fully informed of the latest attempts to destroy the use and enjoyment of private property.

We will not make progress without greater involvement of a wider group of members. We are a voluntary organization and individuals like Heather and Linda contribute despite full time jobs, family obligations etc. Hence there is a pressing need for participation by more volunteers and we would welcome anyone who has some spare time. There is always something that could be done by willing hands.

To be effective WAPRA must assist in the establishment of regional groups formed to fight the same issues. For example there is now a pressing need for a group in the Albany region where a Region Scheme Amendment is being imposed. Similarly throughout the SW there are issues such as water rights, biofuel power generation, carbon credits for residual bush land and many other matters that desperately need local and vocal response. WAPRA has funds sufficient to initiate such organized opposition but needs the cooperation of local leadership. It is impractical that such opposition be centered in Perth rather than in a number of regional cities. We can assist with the blueprint for action and with funding but the energy and insight of local people threatened by such measures is critical. Those feeling the pain are best placed to combat the source of it.

Finally, we will not succeed in limiting the power of Bureaucracy without becoming political. Labor has given government Agencies free reign – and is now unable to control them. Meanwhile the Libs moon about like a mob of lost sheep. We must begin to actively pursue a political voice to reverse the present disastrous trend or the ownership of private property will become simply a liability.
